2026 Fund for Theft and Vandalism – Municipality of Trento

This fund is aimed at **businesses and associations**; it provides a non-repayable grant covering **90% of restoration costs for damage** resulting from reported incidents of theft (attempted or actual) and vandalism affecting business premises and capital assets. The maximum grant amount is **€ 5.000**.

The premises for which the grant is requested must be located within the Municipality of Trento.

Holders of **concessions for trading stalls** or for the direct sale of agricultural products on public land may also apply for the grant. In such cases, the concession must have been issued by the Municipality of Trento.

A maximum of two grant applications may be submitted for the same business unit, provided they relate to two separate incidents of damage.

The incidents of damage must have occurred **between March 16 2026, and December 31 2026**. Applications must include a copy of the formal report regarding the damage, which must have been filed promptly—and in any case no later than three months after becoming aware of the incident—with the competent public security authorities.

Eligible **expenses include** those incurred to repair damage to the premises or to assets essential to the business (e.g., costs for repairing shop windows, fixtures, shutters, entrance doors, outdoor seating areas, and cash registers).

The fund does **not cover the theft of cash floats** or the cost of merchandise displayed for sale.

Expenses covered by insurance are not eligible.

Restoration costs must be substantiated by invoices made out to the entity operating the business and applying for the grant. Businesses must hold an insurance policy covering damage caused by natural disasters and catastrophic events (art. 1, comma 101 Law n. 2013 30 December 2023).
